

## **National History of the 100 Black Men**

At the peak of the Civil Rights Movement in New York during the early 1960s, a group of determined professional men, consisting of public officials, businessmen, lawyers, retailers, government personnel and others who were then known as One Hundred Men agreed to change their name to One Hundred Black Men. The hope was that through re-identification with our Black heritage and with collective effort, they could help chart the direction in human rights and improve the quality of life for Blacks and other minorities. The original chapter, founded in New York City by J. Bruce Llewellyn in 1967, set an example to which all successive chapter aspire.

Now with more than 100 chapters and 10,000 members strong and still growing, 100 Black Men of America, Inc. remains committed to its founding mission: To improve the quality of life in African American communities by improving the educational, economic and social status of African Americans across the entire nation. Dedicated members of 100 Black Men have mentored more than 125,000 youth across the nation. 100 Black Men of America's Four For The Future™ signature program areas are Mentoring, Education, Health & Wellness, Economic Empowerment. Leadership Empowerment serves as an overlay to the 100's Four For the Future programs.

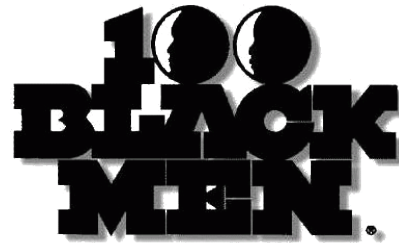

## **Sonoma County Chapter History**

The Sonoma County Chapter of 100 Black Men was established in June 1990. A group of men convened out of the men's breakfast at Community Baptist Church to discuss the problems and expectations of the African-American community and the need for involvement of concerned black men. The decision was made to explore joining The 100 by inviting the Sacramento Chapter President to speak to the founding group. The group voted to create a chapter in Sonoma County. Shortly thereafter articles of incorporation were written and submitted to the State of California and tax exemption submitted to the state and IRS, both were granted in 1991. 100 Black Men of Sonoma County joined the national organization in 1992.

**The 100 Black Men of Sonoma County (100 BMOSC) launched its scholarship program in 1996. Since that date we have provided over \$300,000 in scholarship funds. Annually, the 100 BMOSC award scholarships ranging from \$500 to \$3000 per student per year. The goal of our scholarship program is to motivate and recognize academic achievement by high school and college African American youth. The program funds high school seniors who attend a community college or a four-year colleges or universities and students who plan to attend trade or proprietary school.**
